REPORT CARD: Anti-taxpayer leadership from the big three

Governor Rick Perry

Pushed 100 yr bond debt, sale of TX roads to foreign corporations, more toll roads, and using tax money to build toll roads.

Both pushed bad bills, didn't support our good bills. Both favor tax hikes to raise the revenue needed for roads rather than allocate existing road taxes to roads (that they're currently spending elsewhere). Their committee chairs for transportation (Nichols & Phillips) were two of the worst ever on record for the taxpayer and freedom of mobility.

Other Anti-taxpayer Notables:

Sen. Robert Nichols

Chair, Senate Transportation Committee

He authored nearly every anti-taxpayer, pro-toll bill of the session, including the sale of Texas roads to private, foreign toll operators. He gutted our good bills to ensure free roads could be converted to toll roads and that freeway lanes could be tolled leaving frontage roads as the only non-toll option (and removed the public vote), and authored the bill to use both property tax and sales tax to build/subsidize toll roads, transit and rail projects without a public vote.

Sen. Tommy Williams

Chair, Senate Finance Committee

Single-handedly refused to end diversions of road taxes for non-road purposes. Thwarted EVERY effort to dedicate vehicle sales tax that we already pay to roads. Held existing road tax money (that they're spending on general government) hostage to fee hikes. He wants Texans to pay more in taxes rather than use the road taxes we ALREADY PAY for roads. He also pushed diverting more of our road money to fund ports.

Rep. Larry Phillips

Chair, House Transportation Committee

Bottled up our good bills, fast tracked the bad ones. Carried the bill to sell-off Texas roads to private, foreign toll operators. Patently lied to House members about the bill to convert freeways to toll roads telling them Sen. Donna Campbell's bill SB 1029 removed ALL exceptions to converting free roads to toll roads when the bill, in fact, keeps 5 key loopholes in statute that allows virtually ANY freeway in Texas to be converted into a toll road.

Rep. Drew Darby

House Appropriations Committee

Held road money hostage to fee/tax hikes. Hijacked the effort to dedicate vehicle sales tax that we already pay to roads, instead holding existing road tax money (that they're spending on general government) hostage to fee hikes. He wants Texans to pay more in taxes rather than use the road taxes we ALREADY PAY for roads.

Rep. Linda Harper-Brown

House Transportation Committee

Authored some of the worst transportation bills of the session. One would have used taxpayer money to guarantee the profit of privately-operated roads, another would have given private freight rail companies eminent domain authority, another would have given sweeping new powers to the North Texas Tollway Authority (including using tax money to subsidize loser toll projects - a DOUBLE TAX, and access money from NEW taxing districts as well as use property taxes to build toll roads), and lastly, one to enact an Agenda 21 complete streets policy that would divert road money to hike & bike trails and promote anti-car policies in our cities.

Taxpayer Hero

Rep. Lois Kolkhorst championed our cause and worked on behalf of taxpayers specifically on transportation more than any other House member, not just this session, but EVERY session.

She carried the bill to make tolls come off a road when it is paid for, which would have protected taxpayers from tolls in perpetuity. She also authored one of the strongest property rights bills of the session. Both were thwarted by the Strausappointed committee chairs.

In the special sessions, she single-handedly ensured taxpayers were protected from having the new road funding go to support private toll roads.

Honorable Mention

Rep. Yvonne Davis helped us stop a disastrous anti-taxpayer bill that would have given sweeping new powers to the North Texas Tollway Authority (including using tax money to subsidize loser toll projects — a DOUBLE TAX, and access money from NEW taxing districts as well as use property taxes to build toll roads).

The Methodology

We chose to look at various record votes on bills representative of both property rights and transportation policy. All but one of the bills used in this Report Card became law. This was one of the **WORST** sessions on record for taxpayers relating to transportation policy since 2003 when Governor Rick Perry's policy shift to toll roads, quick take eminent domain, and the Trans Texas Corridor became law.

** These lawmakers grades factor in both their voting record and advocacy on

behalf of taxpayers with regards to transportation, whether it was carrying our good bills, getting pro-taxpayer legislative intent on the record, or otherwise defending transparency and good road policy.

Transportation/tolls:

SB 1730 - (authored by **Sen. Robert Nichols**) Authorizes 23 Comprehensive Development Agreements (Public Private Partnerships) that hand control of our PUBLIC highways or bridges to PRIVATE, even foreign, toll operators that erode our state sovereignty over infrastructure, limit expansion of free routes, guarantee profits, use massive taxpayer subsidies, and charge Texans a premium to drive (75 cents a mile or more!).

SB 1029 - (authored by **Sen. Donna Campbell**) Gives TxDOT a blank check to convert free lanes already built and paid for into toll lanes -- a DOUBLE tax. The original filed bill would have removed all the loopholes in statute, but it was gutted in committee and replaced with the final loophole-laden bill that keeps five loopholes -- the first one giving TxDOT virtual unlimited authority to convert free lanes to toll lanes if it simply designates the project as 'toll' prior to going to contract. One of the loopholes taken out removes the accountability to the public by nixing the public hearing, public vote, and approval by the county commissioners. So the bill actually makes the current statute worse, not better.

SB 1110 - (authored by **Sen. Robert Nichols**), a bill that heists property tax appraisal increases for transportation projects expands the use of Transportation Reinvestment Zones (TRZ) from strictly freeways to toll roads, rail, transit and hike and bike trails, passed easily early in the session indicating that a tax grab at the local level was likely going to be the preferred method of funding roads. The bill also lifts the ban on using sales tax in the zone for road/toll projects.

Local option vehicle registration fee hikes:

HB 1573 - (authored by **Rep. Ruth McClendon**) This is a \$10vehicle registration fee hike for Bexar County, the only one of the three bills that does not require voter approval. Donna Campbell brokered a deal on the final bill that gives the money specifically to the toll authority, who plans to bond up to \$100 million against the new tax revenue to subsidize both toll projects and pay down the agency's debt.

HB 3126 - (authored by Rep. Eddie Lucio, III) Cameron County \$20 fee hike, if voters approve.

HB 1198 - (authored by **Rep. Richard Raymond**) A \$10 fee hike for counties in the Rio Grande Valley as well as El Paso if voters approve.

Property rights:

HB 3459 - (authored by **Rep. Craig Eiland** on behalf of Land Commissioner **Jerry Patterson** who condemned the property involved in the case that prompted the bill) - The legislation guts the Texas Supreme Court decision in favor of property owners along public beaches known as the Severance v. Patterson case. This bill would force the condemnation of private homes (WITHOUT COMPENSATION) along public beaches if the government determines that storms or other 'evulsive' events move the public beach line onto private property. It violates the Texas Constitution and invites more expensive court battles at landowners' expense.

SB 655 - (authored by **Sen. Brian Birdwell**) was about the only good property rights bill that passed, tightening up remaining statutes in the special districts local laws code and the water code to repeal eminent domain for the more general 'public purpose' to the stricter 'public use.'

SPECIAL VOTE FOR SENATE ONLY:

SB 1018 - (authored by **Sen. John Carona**) - Given the reality that the North Texas Tollway Authority lacks toll viable projects and carries a massive debt burden, it sought sweeping new powers to dump its successful 'user fee' model of toll roads financed strictly with revenue bonds (and no taxpayer money), pursuing heaps of taxpayer money to subsidize its loser projects from property taxes to new taxing districts.
